

FOUL MURDER

Woman Killed by Her Divorced Husband.

MRS. JOS. NICKMANN SHOT DOWN WITHOUT WABNING.

A Neighbor Shot But Not Fatally Wounded."

A murder which was entirely without provocation was committed at a late hour yesterday evening 40 miles northwest of Kearney. The murderer was Joseph Nickmann. The murdered person was his lately divorced wife. The story of the tragedy was brought to the city this forenoon by Fred Jasper and Chas. Stockdale, residents of the neighborhood where the crime was committed.

It was not possible to get from Messrs. Jasper and Stockdale an authentic account of the shooting as they were not witnesses and what they had learned about it had been picked up in fragments. It seems however that Mrs. Nickmann had been stopping with the family of a farmer in the neighborhood named Gilg. She had been spending the early part of the evening at the home of another farmer by the name of Glotter. About dusk she was returning to the Gilg residence. On the way she met another neighbor by the name of Anton Janisheck and it is presumed that the two very naturally en-

Janisheck got back to Gilg's and gave the alarm. A posse gathered with loaded shotguns about twenty in number, Julian and Fairchild being with them. They found the team in the thicket, but waited for daylight to make a raid, meantime guarding the ravine to prevent escape. When daylight came Nickmann was found dead in the thicket, having cut his throat from ear to ear with a pocket knife.

The neighbors who were nearly all Germans were terribly enraged over the affair and if Nickmann had been found alive would have made short work of him. As it was they refused to touch the remains pending the arrival of the coroner.
