Though not boasting as long a history as the Woolsey or Henderson funeral homes, Abts Mortuary can boast that it has been owned and operated by the same family for longer than any other Pekin funeral home. Abts was founded in 1934 by John and Gladys Abts, beginning at Sixth and Broadway and then moving in 1942 to its present location at Fifth and Park Avenue, the former home of Pekin Mayor Everett W. Wilson (1893-1894, 1899-1900). Gladys' father had operated a funeral home in Randolph, Neb., and in 1918 Gladys became the first woman in Nebraska to obtain an embalmer's license. Abts Mortuary is now in its fourth generation in the mortuary business.

In 1899 the Board of Embalmers was established to examine and certify embalmers. This board was appointed by the state board of health. The legislature of 1931 required all funeral directors and undertakers in Nebraska to register.
