The following excerpts from the RAVENNA NEWS, Ravenna, Nebraska, were published in August, 1888.

## Thursday, August 2, 1888

Died...At his home near Prairie Center, Layton PALMER, of a complication of diseases. He left Mr POOL's ranch Wednesday of last week and died the next day.
